

RELEASE OF SECURITY INTERESTS

WHEREAS, pursuant to that certain Security Agreement (the "Security Agreement") between Laclede Chain Manufacturing Company ("Laclede"), and General Electric Capital Corporation ("GE Capital") recorded at Trademark Reel 2302, Frame 0381, on May 24, 2001, Laclede granted a security interest to GE Capital in certain intellectual property of Laclede (the "Secured Property"); and

WHEREAS, all of the obligations arising in connection with the grant of the security interest have now been satisfied and GE Credit desires to formally release its security interest and all right, title and interest of GE Credit in and to the Secured Property;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, GE Credit does hereby release and forever discharge and reconvey to Laclede all of GE Credit's security interest in Laclede's right, title, and interest in, to and under the Secured Property and any other patents, trademarks or intellectual property of Laclede, including GE Capital's security interest in the trademark registration identified on Schedule A, attached hereto, so that it is as if the security interest had never been granted by Laclede; and GE Credit does further acknowledge and affirm that all of the rights and remedies of GE Credit with respect to the security interest and mortgage concerning the Secured Property have been and are hereby extinguished; and GE Capital further agrees to perform all additional acts necessary (including executing additional documents) to confirm that GE Credits has no interests under the Security Agreement of any type in, to, or under the Secured Property or any other patents, trademarks or intellectual property of Laclede.

IN WITNESS WHEREOF, GE Credit has caused this Release of Security Interests to be executed and delivered as of the 31st day of December, 2001.
