ASSIGNMENT OF TRADEMARKS

AND

THE UNITED STATES REGISTRATIONS
(AND PENDING REGISTRATIONS) THEREOF

WHEREAS, Robert Hatch d.b.a. Hatch Gloves, a corporation organized and existing under the laws of the State of California, having a place of business at 1656 Walter Street, Ventura, California 93003 ("ASSIGNOR"), acquired, adopted and used, and thereby, owns all rights, title and interests in and to the trademark and United States application for registration thereof, identified in Exhibit A attached hereto and by this reference incorporated herein (the "Mark" and "Application", respectively), along with the goodwill of the businesses appurtenant to said Mark; and

WHEREAS, on September 1, 2000, ASSIGNOR informally assigned its entire rights, title and interests in and to the Mark and Application, and the goodwill appurtenant thereto, to Raven USA, LLC, a corporation organized and existing under the laws of the State of California, having a principal place of business at 14010 Live Oak Avenue, Baldwin Park, California 91706 ("ASSIGNEE"); and

WHEREAS, ASSIGNEE desires to formalize the above-noted assignment, and more specifically, for ASSIGNOR to execute this instrument of assignment, whereby ASSIGNOR formally assigns its entire rights, title and interests in and to the Mark and Application, and the goodwill appurtenant thereto, to ASSIGNEE, nunc pro tunc September 1, 2001, for the purpose, inter alia, of enabling ASSIGNEE to record said assignment with the United States Patent and Trademark Office; and

WHEREAS, ASSIGNOR is willing to execute this instrument of assignment to formalize its above-noted assignment, nunc pro tunc September 1, 2000.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, ASSIGNOR does hereby sell, assign, convey and transfer unto ASSIGNEE, its successors, assigns and legal representatives, nunc pro tunc September 1, 2000, its full and entire rights, title and interests in and to the Mark and Application identified in said Exhibit A, and the attendant goodwill symbolized by the Mark, the same to vest in ASSIGNEE nunc pro tunc September 1, 2000.

ASSIGNOR hereby represents and warrants, nunc pro tunc September 1, 2000, that (i) it is the sole owner of the Mark and the goodwill associated therewith, and the Application relating thereto; (ii) the Application relating thereto was not filed fraudulently or contrary to any provision of Title 15, Chapter 22 of the United States Code; (iii) the United States Registrations thereof are not the subject of any cancellation proceedings in the United States Patent and Trademark Office; (iv) it has granted no licenses to any other party to use the Mark in the United States; (v) it is not aware of any third party who has asserted a claim of any ownership right, title or interest in the Mark or Application, or any other rights or interests therein which are adverse to those of ASSIGNOR; and (vi) it is not a party to any prior agreement, nor has it made any informal commitment or reached any understanding, with any other person or legal entity relating to the Mark and/or Application which would be breached or otherwise violated by the foregoing assignment of the Mark and Application. In this connection, ASSIGNOR states that it makes no other representations or warranties whatsoever, expressed or implied, except as specifically set forth herein.

ASSIGNOR hereby agrees, nunc pro tunc September 1, 2000, that ASSIGNEE shall have the right to record this instrument of assignment with the United States Patent and Trademark Office, so as to establish ASSIGNEE as owner of record of the Mark and Application in the United States.

ASSIGNOR further agrees, nunc pro tunc September 1, 2000, at the request of ASSIGNEE and without charge or cost to ASSIGNEE, to (i) execute and have executed any and all other documents of any kind whatsoever, and to provide whatever information may be required, to carry out the terms and intent of this Assignment; and (ii) fully cooperate with ASSIGNEE, as reasonably required, to enable ASSIGNEE to duly record this instrument of assignment with the United States Patent and Trademark Office, so that ASSIGNEE's ownership of the Mark and Application is duly made of record in the United States Patent and Trademark Office.


