ASSIGNMENT OF TRADEMARKS



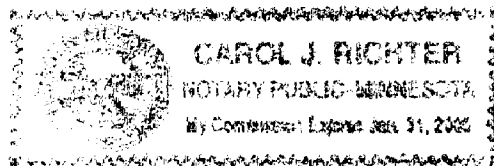
