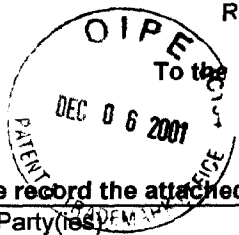




ASSIGNMENT DEEDS
