CERTIFICATE OF AMENDMENT
OF THE CERTIFICATE OF INCORPORATION
OF
BIC PEN CORPORATION

Under Section 805 of the Business Corporation Law

It is hereby certified that:

FIRST: The name of the corporation is BIC Pen Corporation.

SECOND: The Certificate of Incorporation of the corporation was filed by the Department of State on November 14, 1958. The Restated Certificate of Incorporation was filed by the Department of State on April 29, 1971.

THIRD: The Certificate of Incorporation, as heretofore amended and restated, is further amended by this Certificate of Amendment to change the name of the corporation from BIC Pen Corporation to BIC Corporation.

FOURTH: To accomplish the foregoing amendment, Article FIRST of the Certificate of Incorporation, as heretofore amended and restated, is hereby amended to read as follows:

"FIRST: The name of the corporation is BIC Corporation."

FIFTH: The manner in which the foregoing amendment of the Certificate of Incorporation was authorized was by vote of the holders of at least a majority of all of the outstanding shares of the corporation entitled to vote on the said amendment of the Certificate of Incorporation at a meeting of shareholders.
