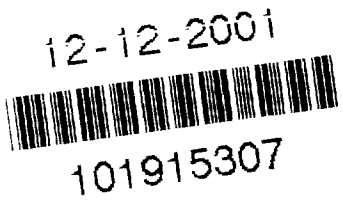

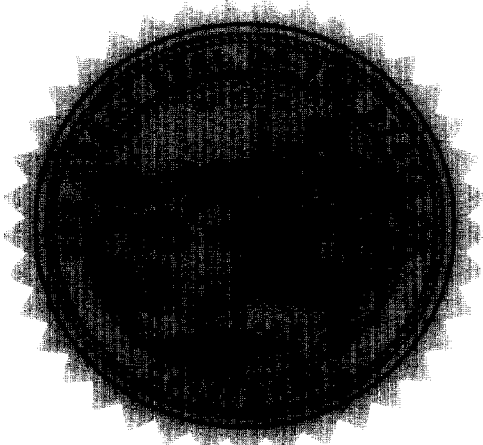

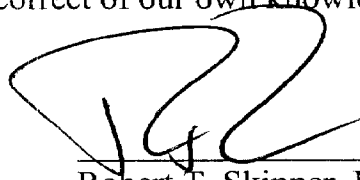
The undersigned certify that:
