FIRSTLY: Through the deed granted in Barcelona on 22nd June 1987, before the Notary, Mr. José Luis Perales Sanz, with protocol number 1493, through the rectifying deed granted in Barcelona on 14th July 1987 before the Notary, Mr. José Solís y Lluch, with protocol number 1635, through the rectifying deed granted in Barcelona on 20th July 1987, before the Notary, Mr. José Luis Perales Sanz, with protocol number 1728 and through other documents that were registered at this Registry on 22nd July 1987 and which led to registration 1^a on page number 100.509, now page number B-92.799, in folio 119 of volume 8.620 of the archives, book 7.864 of section 2^a, the company “GRUPO GRIFOLS, S.A.” was constituted.
