The Assignor agrees with the Assignee that upon request by the Assignee (and at the Assignee's expense) it shall execute all such documents and do all such acts and things as may reasonably be required by the Assignee for securing to or vesting in the Assignee the full benefit of the assignment herein contained.

3. Counterparts

This Assignment may be executed in any number of counterparts, which shall together constitute one Assignment. Any party hereto may enter into this Assignment by signing any such counterpart.

**4. Law and Jurisdiction**

This Assignment shall be governed by and construed in accordance with English law and the parties hereby submit to the exclusive jurisdiction of the English courts in relation to all matters arising out of this Assignment


