BILL OF SALE AND ASSIGNMENT OF TRADEMARK ASSETS

KNOW ALL MEN BY THESE PRESENTS, that the undersigned, AMBRA INC., a Delaware corporation ("Ambra"), for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, received from HUGO BOSS AG, a German joint stock company, ("Hugo Boss") on this November 29, 2001, does hereby assign, transfer, deliver and set over to Hugo Boss and Hugo Boss' successors and assigns forever, and Hugo Boss hereby acquires from Ambra, all of Ambra's right, title and interest in and to all of the following assets, properties and rights of Ambra throughout the world (the "Trademark Assets") to be held and enjoyed by Hugo Boss for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives forever, as fully and entirely as the same would have been held and enjoyed by Ambra had the assignment and sale set forth herein not been made:


(a) Any and all right, title and interest of Ambra in and to the trademarks, service marks, trade names, logos, insignias, designs, copyrights (if any), and other proprietary interests therein, containing the term "BOSS" or constituting a stylized B, throughout the world, including, without limitation, all registrations and applications for registration therefor throughout the world, including those trademark registrations and applications listed on Exhibit A hereto together with the good will associated therewith, (the "Trademarks") and including all causes of action and the proceeds thereof in favor of Ambra heretofore accrued or hereafter accruing with respect to the Trademarks;

(b) All right, title, interest in and to all files that Ambra has within its possession or control relating to the Trademarks;

From and after the date hereof, Ambra shall, upon request and at the expense of Hugo Boss but without further consideration, do, execute, acknowledge, deliver and file, or shall cause to be done, executed, acknowledged, delivered and filed, all such further acts, deeds, transfers, conveyances, assignments or assurances as may be reasonably requested by Hugo Boss to transfer, convey and assign to Hugo Boss possession and use of the Trademark Assets to comply with all applicable legal requirements to effect such transfers, conveyances and assignments.
