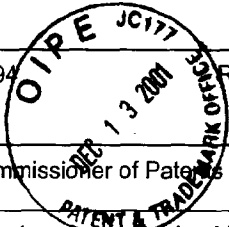

RELEASE OF TRADEMARK ASSIGNMENT

WHEREAS, NetObjects, Inc., a Delaware corporation, having its principal offices at 2055 Woodside Road, Redwood City, CA 94061, has adopted, used or had an intent-to-use the Trademark listed in the attached **Exhibit A**, now registered or in the process of registration in the United States Patent and Trademark Office;

WHEREAS, The Boeing Company, a Delaware corporation, entered into that certain Assignment and Assumption of Liabilities Agreement dated October 1, 1999 (the "Assignment Agreement"), with Boeing Management Company, a Delaware corporation (hereinafter collectively referred to as "Boeing") to transfer trademarks to Boeing Management Company; a true and correct copy of which was recorded by the United States Patent and Trademark Office ("PTO") on January 3, 2001, at Reel 002200, Frame 0134;


WHEREAS, The schedule to the Assignment Agreement contained a typographical error which caused the NETOBJECTS FUSION registration listed in Exhibit A to be inadvertently assigned to Boeing Management Company; and

WHEREAS, Boeing has filed with the PTO on June 12, 2001, a Request for Corrected Assignment Document to reassign the NETOBJECTS FUSION registration to NetObjects, Inc. and to correct the typographical errors in the schedule to the Assignment Agreement; and has left numerous messages with the PTO Examiner requesting that this correction be made.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Boeing hereby:

1. releases and reassigns to NetObjects, Inc. any and all liens, security interests, right, title and interest of Boeing pursuant to the Assignment Agreement in the Trademark which is described more fully on **Exhibit A**; and
2. authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the release hereby given.
