WHEREAS, the agreement was recorded with the United States Patent and Trademark Office on **April 2, 2001**, at Reel/Frame **002270/0304**; and


WHEREAS, THE Secured Party has agreed to terminate and release its security interest in the Trademarks as herein provided;

IN WITNESS WHEREOF, the Secured Party has executed this Termination and Release, to take effect as of the date first set forth above.


