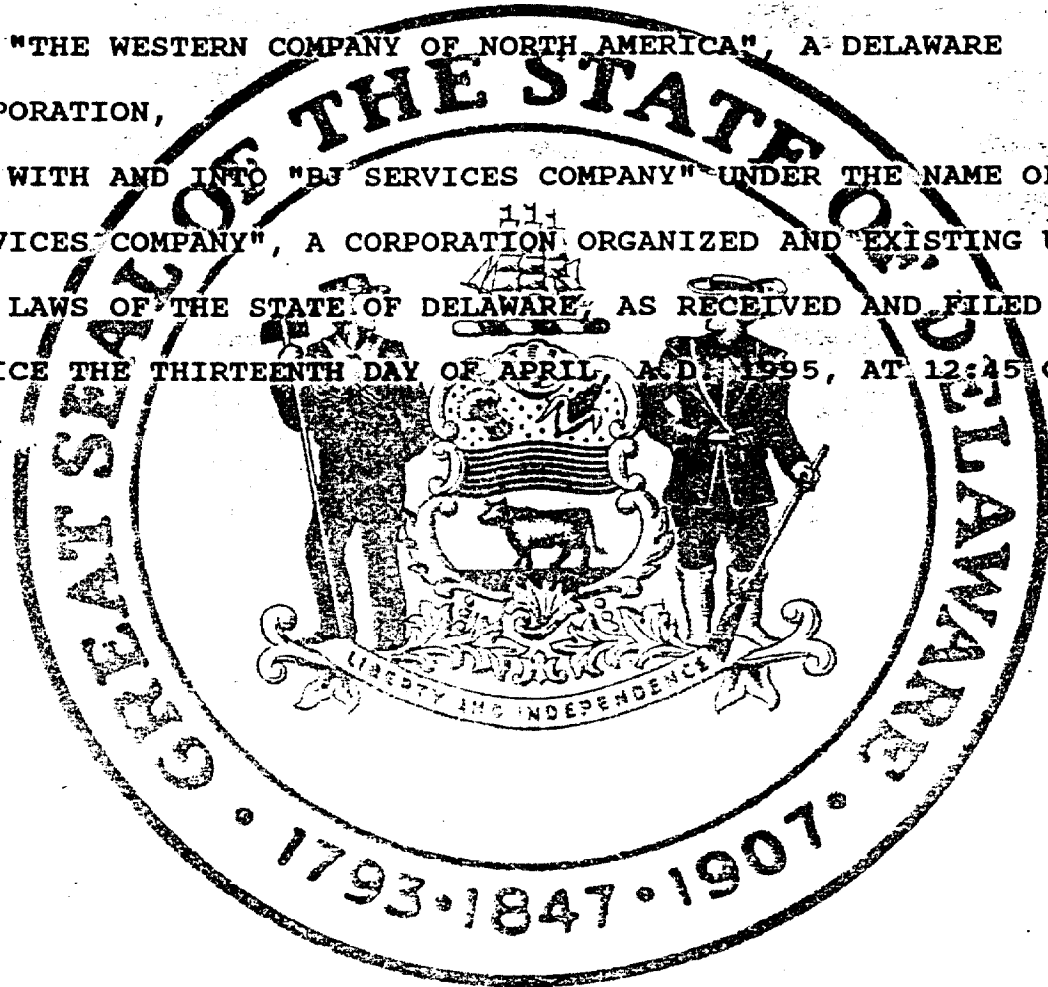

SEVENTH. That this Certificate of Merger shall be effective when this Certificate of Merger is filed with the Secretary of State of the State of Delaware.

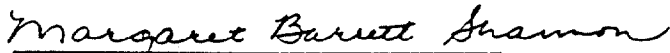
