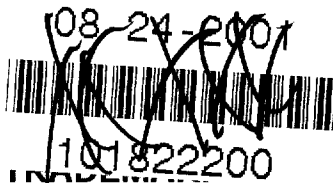





RELEASE OF SECURITY INTEREST
