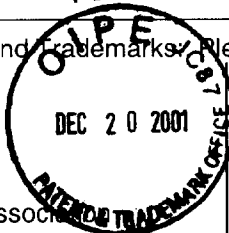

ASSIGNMENT OF TRADEMARK RIGHTS



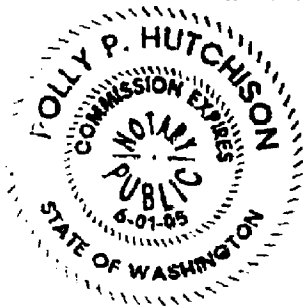
