The Hotsy Corporation, a corporation organized and existing under and by virtue of the General Corporation Law of the State of Colorado (the "Corporation"), does hereby certify:

FIRST: That pursuant to an unanimous written consent of the Corporation's Board of Directors dated December 4, 2001, resolutions were adopted setting forth a proposed amendment to the Articles of Incorporation of the Corporation, declaring said amendment to be advisable and proposing to submit said amendment to the stockholders of the Corporation for consideration thereof. The resolution setting forth the proposed amendment is as follows:

RESOLVED, that the Board of Directors of the Corporation hereby declare it advisable and in the best interest of the Corporation that the name of the Corporation be changed to "C-Tech Industries, Inc." and that Article I of the Articles of Incorporation be amended to read as follows:

Article I

Name

The name of the Corporation shall be "C-Tech Industries, Inc."

SECOND: That in lieu of a meeting and vote of the sole stockholder, the sole holder of issued and outstanding shares of capital stock of the Corporation has given its written consent to said amendment in accordance with the provisions of Section 7-107-104 of the General Corporation Law of the State of Colorado.

THIRD: That the aforesaid amendment was duly adopted in accordance with applicable provisions of Sections 7-110-103 and 7-107-104 of the General Corporation Law of the State of Colorado.
