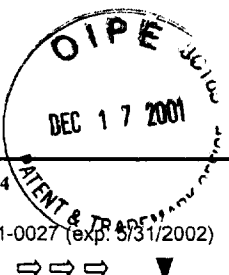

OF AMENDED AND RESTATED
TRADEMARK COLLATERAL SECURITY AND PLEDGE AGREEMENT

SALESLINK CORPORATION

TERMINATION AND RELEASE OF AMENDED AND RESTATED TRADEMARK COLLATERAL SECURITY AND PLEDGE AGREEMENT, dated as of October 30, 2001, by **FLEET NATIONAL BANK** (f/k/a BankBoston, N.A.), a national banking association with its head office at 100 Federal Street, Boston, Massachusetts 02110, as agent (hereinafter in such capacity, the "Agent") for itself and the other lending institutions (hereinafter collectively the "Banks"), in connection with the Amended and Restated Revolving Credit and Term Loan Agreement, dated as of June 11, 1998 (as heretofore amended, and in effect, the "Credit Agreement"), by and among Saleslink Corporation, a Delaware corporation (the "Company"), certain affiliates of the Company, the Agent and the Banks.


WHEREAS, in connection with the Credit Agreement, the Company and the Agent entered into a Amended and Restated Trademark Collateral Security and Pledge Agreement, dated as of June 11 1998 (the "Trademark Agreement"), which Trademark Agreement was recorded January 10, 2000 with the United States Patent and Trademark Office at Reel 002016, Frame 0494 for the purpose of securing payment and performance of the Obligations (as defined in the Credit Agreement);

WHEREAS, pursuant to the Trademark Agreement, the Company granted to the Agent a security interest in, and granted, assigned and conveyed to the Agent, by way of collateral security, the Company's entire right, title and interest in and to, the Pledged Trademarks (as defined in the Trademark Agreement); and

WHEREAS, the Agent has agreed to terminate and release the Trademark Agreement and assign and transfer to the Company its right, title and interest in the Pledged Trademarks as herein provided;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates and releases the Trademark Agreement and assigns and transfers to the Company, without representation, warranty or recourse, all of the Agent's right, title and interest in and to the Pledged Trademarks, including without limitation the trademarks listed on Exhibit A attached hereto, effective as of the date set forth above.
