## RELEASE OF SECURITY INTEREST IN TRADEMARKS AND PATENTS

THIS RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS is dated as of October 12, 2000 by The Chase Manhattan Bank, as agent (the "Agent") for the lenders (the "Lenders") named in the Credit Agreement dated as of June 30, 1999, among The Benjamin Ansehl Company (the "Company"), the guarantors named therein, the Lenders and the Agent (as amended or modified, the "Credit Agreement").

WHEREAS, the Agent and the Company entered into that certain "Security Agreement and Mortgage - Trademarks and Patents" dated as of June 30, 1999 (the "IP Security Agreement");

WHEREAS, the IP Security Agreement granted to the Agent, for its own benefit and for the benefit of the Lenders, a security interest in and to, among other things, (i) all of the Company's right, title and interest in and to each of the Trademarks (as defined in the IP Security Agreement) and the goodwill of the business symbolized by each of the Trademarks, all customer lists and other records of the Company relating to the distribution of products bearing the Trademarks and each of the trademark registrations and applications described in Schedule A attached hereto, (ii) all of the Company's right, title and interest in and to each of the Patents (as defined in the IP Security Agreement) and each of the patent registrations and applications listed on Schedule B attached hereto, and (iii) any and all proceeds of the foregoing (collectively, the "IP Collateral"); as security for certain obligations of the Company to the Lenders under the Credit Agreement (the "Obligations");

WHEREAS, the Company executed and delivered to the Agent that certain Assignment for Security (Trademarks) dated as of June 30, 1999;

WHEREAS, the Company executed and delivered to the Agent that certain Assignment for Security (Patents) dated as of June 30, 1999;

WHEREAS, Chemical Bank (predecessor in interest to The Chase Manhattan Bank), as Agent ("Chemical Bank"), and the Company entered into that certain "Security Agreement 2nd Mortgage - Trademarks and Patents" dated as of April 6, 1990 (the "Chemical Bank Security Agreement"), pursuant to which the Company granted Chemical Bank a security interest in and to each of the Trademarks (as defined in the Chemical Bank Security Agreement) and the goodwill of the business symbolized by each of the Trademarks, all customer lists and other records of the Company relating to the distribution of products bearing the Trademarks and each of the trademark registrations and applications described in Schedule C attached hereto, (ii) all of the Company's right, title and interest in and to each of the Patents (as defined in the Chemical Bank Security Agreement) and each of the patent registrations and applications listed on Schedule D attached hereto, and (iii) any and all proceeds of the foregoing (collectively, the "Chemical Bank IP Collateral"), as security for certain obligations of the Company to the Lenders under the Credit Agreement dated April 6, 1990 (the "Chemical Bank Obligations");

WHEREAS, the Company executed and delivered to Chemical Bank that certain Assignment for Security (Trademarks) dated as of April 6, 1990;

WHEREAS, the Company executed and delivered to Chemical Bank that certain Assignment for Security (Patents) dated as of April 6, 1990;

WHEREAS, the Company has requested that the Agent release its security interest in the IP Collateral in connection with the satisfaction of the Obligations;

WHEREAS, the Chemical Bank Obligations have been fully satisfied and the Company has requested that the Agent (successor in interest to Chemical Bank) release its security interest in the Chemical Bank IP Collateral; and

WHEREAS, the Company has further requested that, to the extent the records of the United States Patent and Trademark Office reflect a complete transfer and assignment of the IP Collateral and the Chemical Bank IP Collateral to Agent, rather than a grant of a security interest, that the Agent reassign and transfer to the Company all right, title and interest in and to the IP Collateral and the Chemical Bank IP Collateral;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. The Agent hereby fully releases, terminates and forever discharges its security interests in and liens on the IP Collateral and the Chemical Bank IP Collateral. To the extent the records of the United States Patent and Trademark Office reflect a complete transfer and assignment of the IP Collateral to Agent and the Chemical Bank IP Collateral to Chemical Bank, rather than the grant of a security interest, the Agent hereby assigns, transfers and conveys to the Company all right, title and interest in and to the IP Collateral and the Chemical Bank IP Collateral.

2. The Agent further agrees, at the sole cost and expense of the Company, to perform all acts reasonably necessary to effect the release and termination of its security interest in and liens on the IP Collateral and the Chemical Bank IP Collateral, including, but not limited to the recording, filing and entering into any agreements, documents, forms or papers needed to accomplish such release and termination.
