RELEASE (this "Release"), made as of this 21 day of December, 2001, by FLEET NATIONAL BANK ("Fleet"), as administrative agent (in such capacity, the "Administrative Agent") for itself and the various financial institutions and other Persons (together with their respective successors and assigns being hereinafter referred to collectively as the "Lenders") party to the Credit Agreement, dated as of October 11, 2000 (as amended and restated by the Amended and Restated Credit Agreement, dated as of November 7, 2000, and as amended, supplemented, amended and restated and otherwise modified from time to time, the "Credit Agreement"), among Advanstar Communications Inc. (the "Borrower"), the Lenders, Credit Suisse First Boston, as Lead Arranger and Syndication Agent, and the Administrative Agent. The Administrative Agent hereby releases and discharges all Liens on the Copyright Collateral set forth on Schedule A attached hereto, including, without limitation, all proceeds thereof and the right to sue for past, present and future infringements, together with the goodwill of the business symbolized thereby and the registrations and applications thereof.

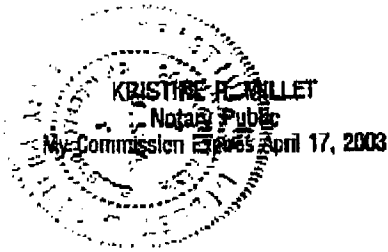
