ASSIGNMENT OF TRADEMARK AND INTEREST

This ASSIGNMENT OF TRADEMARK AND INTEREST ("Assignment") is made effective this 21ST day of November, 2001 by BINGO CARD MINDER CORPORATION ("BCM"), a Delaware corporation, whose principal place of business is 900 Sandhill Road, Reno, Nevada 89511; and GAMETECH INTERNATIONAL, INC. ("GAMETECH"), a Delaware corporation whose principal place of business is 900 Sandhill Road, Reno, Nevada 89511.

RECITALS

A. BCM is the owner of all rights, title, uses, interests, and good-will of the trademarks:

"TED," as registered in the federal register of the U.S. Patent and Trademark Office (serial number 75008016, registration number 2076334), and through common law rights arising from first use of the Mark in interstate commerce at least as early as October 16, 1995;

"THE ELECTRONIC DAUBER," as registered in the federal register of the U.S. Patent and Trademark Office (serial number 75008014, registration number 2127889), and through common law rights arising from first use of the Mark in interstate commerce at least as early as October 16, 1995; and

"BINGO CARD MINDER," as registered in the federal register of the U.S. Patent and Trademark Office (serial number 75008015, registration number 2035175) and through common law rights arising from first use of the Mark in interstate commerce at least as early as May 20, 1988, (collectively the "Marks").

B. GAMETECH desires to acquire, and BCM desires to transfer the trademarks including all related trademark rights, interest and good-will, all as more particularly set forth below.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Recitals: The above recitals A through B are hereby acknowledged as true and correct and are incorporated herein.

2. Assignment of Trademarks: BCM hereby assigns, conveys, sells, transfers, and delivers to GAMETECH permanently, exclusively and irrevocably its trademarks "TED," "THE ELECTRONIC DAUBER," and "BINGO CARD MINDER," including all rights, title, uses, interests and good-will relating to said Marks whether derived through common law or through federal or state statutory registration.


3. Assignment of Interest: BCM does hereby permanently and irrevocably sell, assign, and set over unto GAMETECH, all of its right, title, good-will and interest in and to its trademarks "TED," "THE ELECTRONIC DAUBER," and "BINGO CARD MINDER."



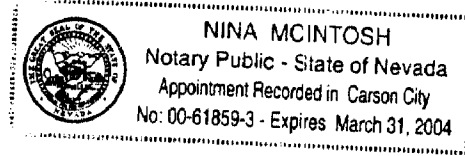
