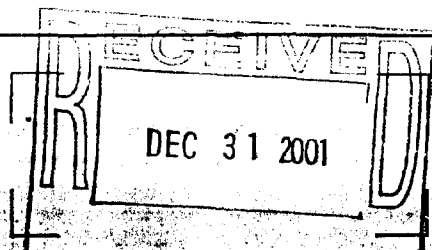

ASSIGNMENT OF TRADEMARKS

SONOCO-CRELLIN hereby agrees to communicate to SONOCO, its successors, assigns, or legal representatives, any facts known to SONOCO-CRELLIN respecting said Trademarks, to testify at any legal proceedings relating thereto, sign all lawful papers, execute all renewal and extension applications required by SONOCO, make all rightful oaths, and, in addition, to execute any and all documents that may be required in order that SONOCO may make applications for registrations on Trademarks in foreign countries in its own name. And, SONOCO-CRELLIN does hereby authorize and request the Commissioner of Patents and Trademarks to issue any registrations which may be granted for said Trademarks unto SONOCO, its successors and assigns, in accordance with this assignment.
