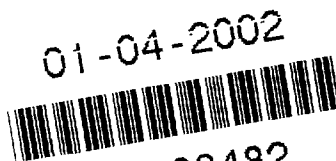

ASSIGNMENT


