#### INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Intellectual Property Security Agreement (as amended, supplemented or otherwise modified from time to time, the "Intellectual Property Security Agreement") is made and effective as of November 28, 2001, by NUMATICS, INCORPORATED, a Michigan corporation (the "Parent"), MICRO-FILTRATION, INC., a Michigan corporation, NUMATION INC., a Michigan corporation, NUMATECH, INC., a Michigan corporation, ULTRA AIR PRODUCTS, INC., a Michigan corporation, MICROSMITH, INC., an Arizona corporation, and EMPIRE AIR SYSTEMS, INC., a New York corporation, NUMATICS, GMBH, a corporation organized under the laws of the Federal Republic of Germany ("Numatics Germany"), and NUMATICS LTD., a Canadian corporation ("Numatics Canada") (Parent and the foregoing entities, including any successors or permitted assignees thereof, each, the "Grantor," and collectively, the "Grantors"), in favor of AMERICAN CAPITAL FINANCIAL SERVICES, INC., a Delaware corporation, as agent for each of the Purchasers from time to time party to the Note Purchase Agreement referred to below (the "Agent"). Capitalized terms used in this Intellectual Property Security Agreement and not otherwise defined shall have the respective meanings ascribed to such terms in the Note Purchase Agreement.

### **RECITALS**

WHEREAS, pursuant to the Note Purchase Agreement (as amended, supplemented or otherwise modified from time to time, the "Note Purchase Agreement") dated as of the date hereof by and among the Grantors, the Agent and the Purchasers from time to time party thereto (the "Purchasers"), the Purchasers have agreed, subject to the terms and conditions set forth therein, to purchase certain Term A Notes of the Parent, Numatics Canada and Numatics Germany (collectively, the "Notes"); and

WHEREAS, it is a condition precedent to the obligation of the Agent and the Purchasers to execute and perform under the Note Purchase Agreement that Grantors shall have executed and delivered this Intellectual Property Security Agreement to the Agent, for the ratable benefit of each of the Purchasers;

NOW, THEREFORE, in consideration of the willingness of the Agent and the Purchasers to enter into the Note Purchase Agreement and to agree, subject to the terms and conditions set forth therein, to purchase the Notes from Parent, Numatics Canada and Numatics Germany pursuant thereto, and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed as follows:

1. <u>Grant of Security Interest</u>. To secure the Grantors' prompt, punctual and faithful payment of the Notes and the performance of all and each of the obligations under the Note Purchase Agreement, each Grantor hereby grants to Agent, for its benefit and the ratable benefit of each of the Purchasers, a continuing first priority security interest in all of the right, title and interest of such Grantors in and to any and all of the following collateral, whether now owned or hereafter acquired (the "Intellectual Property Collateral"):

The U.S and foreign copyrights, associated copyright registrations and applications for copyright registration, and copyright licenses (to the extent permitted under the terms thereof) set forth on Schedule A attached hereto (collectively, the "Copyrights"); and

The U.S. and foreign patents and patent applications, and patent licenses set forth on <u>Schedule B</u> attached hereto, including, without limitation, divisions, continuations, renewals, reissues, extensions and continuations-in-part of the same (collectively, the "<u>Patents</u>"); and

The U.S., state and foreign trademark and service mark registrations, trademark and service mark applications, and trademark and service mark licenses (to the extent permitted under the terms thereof) set forth on <u>Schedule C</u> attached hereto and all goodwill associated with the foregoing (collectively, the "<u>Trademarks</u>"); and

The domain names and registrations set forth on <u>Schedule D</u> attached hereto and all goodwill associated with the foregoing (collectively, the "<u>Domain Names</u>"); and

- (a) Any and all claims and causes of action for past, present or future infringement of any of the Intellectual Property Collateral, with the right, but not the obligation, to sue for and collect damages for infringement of the Intellectual Property Collateral;
- (b) Any and all licenses or rights granted under any of the Intellectual Property Collateral, and all license fees and royalties arising from such licenses or rights, in each case to the extent permitted by such licenses or rights;
- (c) Any and all amendments, renewals, extensions, reissuances and replacements of any of the Intellectual Property Collateral; and
  - (d) Any and all products and proceeds of any of the foregoing.

Notwithstanding the foregoing, with respect to the Intellectual Property Collateral located in Canada, the Intellectual Property Collateral shall not include the last day of the term of any lease (but upon enforcement of Agent's rights hereunder, Agent shall stand possessed of such last day in trust to assign the same to any person acquiring such term).

2. <u>Requested Recordation</u>. Each Grantor authorizes and requests that the Register of Copyrights and the Commissioner of Patents and Trademarks (and any state, foreign or other authorities to which this Intellectual Property Security Agreement is submitted) file and record this Intellectual Property Security Agreement (and any corresponding or separate application forms of such jurisdiction) in order to publicly reflect the interests of the Agent and the Purchasers in the Intellectual Property Collateral.

### 3. Reserved.

4. <u>Power of Attorney</u>. Each Grantor hereby irrevocably grants the Agent for its benefit and for the ratable benefit of the Purchasers a power of attorney, to act as such Grantor's attorney-in-fact, with full authority in the name, place and stead of such Grantor, from time to time in the Agent's discretion, to take any action and to execute any instrument which the Agent

may deem reasonably necessary or advisable to accomplish the purposes of this Intellectual Property Security Agreement. This authority includes, without limitation, the following:

- (a) To modify or amend (in sole discretion of the Agent and the Purchasers and without first obtaining such Grantor's approval of or signature thereto) Schedule A, Schedule B, Schedule C, and/or Schedule D hereof, as appropriate, to include references to any registered intellectual property (or application or license therefor) acquired by such Grantor after the execution hereof or to delete any reference to any Intellectual Property Collateral in which such Grantor no longer has or claims any right, title or interest;
- (b) To execute, file and pursue (in sole discretion of the Agent and the Purchasers and without first obtaining such Grantor's approval of or signature thereto, unless otherwise prohibited by applicable law) any application, form or other document in order to perfect, maintain, continue or otherwise protect the Agent's interest or such Grantor's rights in the Intellectual Property Collateral, including, without limitation, executing and filing (i) any financing statement, financing change statement, any continuation statement or any amendment thereto, and (ii) any document in any proceeding before the United States Patent and Trademark Office, the United States Copyright Office, the Canadian Intellectual Property Office, the Canadian Industrial Designs Office or the relevant office of any state or foreign jurisdiction (including, without limitation, the filing of applications for renewal, affidavits of use, affidavits of incontestability and opposition, interference and cancellation proceedings) and to pay any fees and taxes in connection therewith or otherwise;
- (c) To execute any document required to acknowledge, register or perfect the interest of the Agent and the Purchasers in any part of the Intellectual Property Collateral without the signature of such Grantor unless prohibited by applicable law; and
- (d) Upon the occurrence and during the continuation of an Event of Default, to (i) endorse the respective Loan Party's name on all applications, documents, papers and instruments necessary or desirable for Agent in the use of the Intellectual Property Collateral or (ii) take any other actions with respect to the Intellectual Property Collateral as Agent deems to be in the best interest of Agent, or (iii) grant or issue any exclusive or non-exclusive license under the Intellectual Property Collateral to anyone, or (iv) assign, pledge, convey or otherwise transfer title in or dispose of the Intellectual Property Collateral to anyone.

The foregoing power of attorney is coupled with an interest and is irrevocable.

5. Release. Unless otherwise agreed in writing by the parties, the security interests granted herein will terminate (and all rights to the Intellectual Property Collateral will revert to each of the Grantors) upon satisfaction of the following conditions: (a) payment and performance in full of all the Obligations secured hereby (unconditionally and indefeasibly) and (b) the termination of the Note Purchase Agreement. Upon any such termination, the Agent (at the Grantors' request and sole expense) will promptly execute and deliver to the Grantors (without any representation, warranty or recourse of any kind whatsoever) such documents as the Grantors may reasonably request and provided to the Agent to evidence such termination.

6. <u>Newly Registered Copyrights, Patents and Trademarks</u>. Each Grantor hereby agrees to provide the Agent, for its benefit and the benefit of each of the Purchasers, on a monthly basis, a schedule of newly registered Copyrights, Patents and Trademarks.

### 7. Miscellaneous.

- (a) This Intellectual Property Security Agreement has been entered into in conjunction with the provisions of and the security interest granted to the Agent, for its benefit and the ratable benefit of the Purchasers, under the Note Purchase Agreement. The rights and remedies of the Grantors and the Agent with respect to the security interests granted herein are in addition and without prejudice to those set forth in the Note Purchase Agreement, all terms and provisions of which are hereby incorporated herein by reference. In the event that any provisions of this Intellectual Property Security Agreement are deemed to conflict with the Note Purchase Agreement or the other Purchase Documents, the provisions of the Note Purchase Agreement or the other Purchase Documents shall govern.
- (b) This Intellectual Property Security Agreement may be executed in any number of counterparts with the same effect as if all the signatures on such counterparts appeared on one document; each such counterpart will be deemed to be an original but all counterparts together will constitute one and the same instrument.


