ASSIGNMENT

WHEREAS, Moran Foods, Inc., a corporation of the State of Missouri with offices at 100 Corporate Office Drive, Earth City, Missouri, U.S.A. ("Moran"), is the owner of the trademark SIERRA MIGUEL and intent-to-use United States Trademark Application Serial No. 75/001,873 therefor, (hereinafter this trademark and trademark application shall be referred to collectively as the "Mark"); and

WHEREAS, Save-A-Lot Food Stores, Inc., a corporation of the State of Missouri with offices at 100 Corporate Office Drive, Earth City, Missouri, U.S.A. ("Save-A-Lot"), is desirous of acquiring all of Moran's right, title and interest in and to the Mark and any registration issuing therefrom, pursuant to a Conveyance Agreement between Moran and Save-A-Lot executed October 3, 1999 in connection with a plan of corporate realignment.

WHEREAS, Save-A-Lot has acquired and is acquiring the portion of Moran's business to which the Mark pertains, which business is ongoing and existing.

NOW THEREFORE, for one dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Moran has, and hereby does, sell, assign and transfer unto Save-A-Lot the entire right, title and interest in and to the Mark and any registration issuing therefrom, together with the goodwill associated therewith, and the right to sue for, and recover for, any past infringements thereof, to be held and enjoyed by Save-A-Lot, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Moran had no sale and assignment of said Mark been made.
