**ASSIGNMENT AND RELEASE OF INTEREST IN  
TRADEMARKS AS SECURITY INTEREST**

**AGREEMENT** made as of this **24th** day of **October 2001**, by and between **FLEET NATIONAL BANK** as successor by merger to **CONNECTICUT BANK AND TRUST COMPANY, N.A.** (the "Lender"), and **BACOU USA SAFETY, INC.**, a Delaware corporation, as successor by assignment to **COMASEC, INC.**, a Connecticut corporation (the "Assignor").

**W I T N E S S E T H :**

**WHEREAS**, pursuant to that certain Security Agreement dated as of December 29, 1986 (the "Security Agreement"), between Lender and Assignor, Assignor assigned to Lender all of its copyrights, trademarks and tradenames then existing and arising thereafter, including, without limitation, those listed on the attached Exhibit A (the "Trademarks") as security for the obligations set forth in the Security Agreement; and

**WHEREAS**, Assignor has satisfied said obligations and Lender has agreed to release its security interest in the Trademarks and reassign all right, title and interest on and to all of the Trademarks to Assignor.


**NOW, THEREFORE**, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which hereby are acknowledged, Lender and Assignor hereby agree as follows:

1. Lender hereby assigns and transfers to Assignor, without recourse, its entire right, title and interest in and to all of the Trademarks and the other collateral described in the Security Agreement.
2. Lender hereby releases its mortgage and security interest in the Trademarks and in the other collateral described in the Security Agreement, and agrees to deliver any and all UCC-3 Termination Statements, together with any and all other release documents which may be necessary to effect this Agreement.
3. Assignor and Lender hereby acknowledge and agree that the Security Agreement is terminated as of the date of this Agreement.




