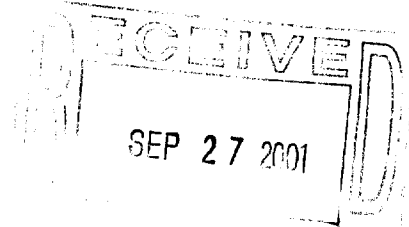




1. Paragraph 1 is hereby deleted in its entirety and the following inserted in lieu thereof:
