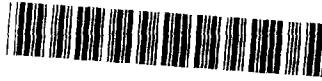

DOVEBID, INC. hereby certifies that pursuant to Title 8, Section 264(c) and Title 6, Section 18-209(c) of the Delaware General Corporation Law, the undersigned executes the following Certificate of Merger:

FIRST: The name of the surviving corporation is DOVEBID, INC., a Delaware corporation (the "Surviving Corporation"), and the name of the limited liability company being merged into this surviving corporation is DOVE BROTHERS, LLC, a Delaware limited liability company (the "Disappearing LLC").
