GRANT OF SECURITY INTEREST

INC., as sole advisor, lead arranger and sole book manager, BEAR STEARNS CORPORATE LENDING INC., as syndication agent, LEHMAN COMMERCIAL PAPER INC., as administrative agent (in such capacity, the "Administrative Agent"), LEHMAN BROTHERS INC., as co-arranger, and the several Lenders from time to time party thereto (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement").

WITNESSETH:

WHEREAS, pursuant to the Credit Agreement, the Lenders have severally agreed to make Loans and other extensions of credit to the Borrower upon the terms and subject to the conditions set forth therein;

WHEREAS, in connection with the Credit Agreement, the Obligors and certain of their Subsidiaries have executed and delivered a Guarantee and Collateral Agreement dated as of September 28, 2001 in favor of the Administrative Agent (together with all amendments and modifications, if any, from time to time thereafter made thereto, the "Guarantee and Collateral Agreement");

WHEREAS, pursuant to the Guarantee and Collateral Agreement, the Obligors pledged and granted to the Administrative Agent for the ratable benefit of the Secured Parties a continuing security interest in, inter alia, all Intellectual Property, including the Trademarks, Patents, and Copyrights; and

WHEREAS, the Obligors have duly authorized the execution, delivery and performance of this Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and in order to induce the Lenders to make the Loans and other extensions of credit to the Borrower pursuant to the Credit Agreement, the Obligors hereby agree, for the benefit of the Administrative Agent and the Secured Parties, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or if the context otherwise requires, terms used in this Agreement shall have the meanings provided in the Credit Agreement,

if provided therein, or, if not provided therein, in the Guarantee and Collateral Agreement, if provided therein.

SECTION 2. Grant of Security Interest. The Obligors grant to the Administrative Agent, for the ratable benefit of the Secured Parties, a security interest in all of the Intellectual Property (as defined in the Guarantee and Collateral Agreement, and including, without limitation, those items listed on Schedule A hereto) now owned or at any time hereafter acquired by the Obligors or in which the Obligors now have or at any time in the future may acquire any right, title or interest, wherever located, as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of the Obligors' Obligations. The Obligors do hereby acknowledge and affirm that the rights and remedies of the Administrative Agent and the Secured Parties with respect to the security interest in the Intellectual Property granted hereunder and under the Guarantee and Collateral Agreement are as set forth in the Credit Agreement and the Guarantee and Collateral Agreement, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein.

SECTION 3. Purpose. This Agreement has been executed and delivered by the Obligors for the purpose of recording the grant of security interest in the Guarantee and Collateral Agreement with the United States Patent and Trademark Office and the United States Copyright Office. The security interest granted hereby has been granted to the Secured Parties in connection with the Guarantee and Collateral Agreement and is expressly subject to the terms and conditions thereof.
