RELEASE OF SECURITY INTEREST IN TRADEMARKS

RELEASE, dated August 8, 2001 granted by TransAmerica Business Credit Corporation, in its capacity as lender ("TransAmerica").

W I T N E S S E T H:

WHEREAS, Cimlinc, Inc. ("Cimlinc") and TransAmerica have entered into a Security Agreement, in Trademarks dated November 5, 1997, (the "Security Agreement"), pursuant to which Cimlinc granted to TransAmerica a security interest in all of the [Trademark Collateral] (as such term is defined in the Security Agreement);

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on November 11, 1997 on Reel/Frame 1656/0007 with respect to various trademarks (the "Released Trademarks"), including, without limitation, the United States trademarks listed on Schedule A attached hereto and forming a part hereof;

WHEREAS, Cimlinc assigned all of its assets, including, without limitation, to Michael J. Eber, as Assignee for the Benefit of Creditors of Cimlinc ("Assignee"), pursuant to that certain Trust Agreement for the Benefit of Creditors of Cimlinc, Inc. dated July 12, 2001;

WHEREAS, The Boeing Company purchased certain of the assets of Cimlinc, including the Released Trademarks at an auction held by the Assignee on July 31, 2001;

WHEREAS, Cimlinc and the Assignor have requested TransAmerica to release of record its lien upon the Released Trademarks; and

WHEREAS, TransAmerica is willing to release such liens;

NOW, THEREFORE, TransAmerica hereby releases its entire right and interest in the Released Trademarks created by the Security Agreement, and the lien and security interest granted to Agent in the Released Trademarks shall hereupon cease and terminate.

RESOLVED, FURTHER, TransAmerica hereby agrees to execute and deliver all such releases and documents and to take such actions as may be reasonably required to release and terminate the lien and security interest granted to TransAmerica under the Security Agreement.
