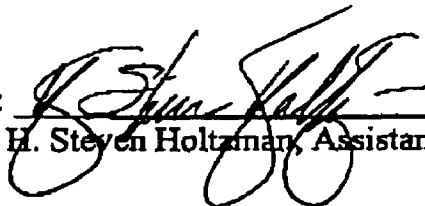
FIRST: The name of the Limited Partnership is Home Shopping Club LP.
