## ASSIGNMENT OF TRADEMARKS AND SERVICE MARKS

This Agreement is made as of the 1<sup>st</sup> day of April, 2001 between BBBL, Inc., a Delaware corporation, having a place of business at 650 Liberty Avenue, Union, New Jersey 07083 ("BBBL") and Bed Bath & Beyond Procurement Co. Inc., a New York corporation, having a place of business at 110 Bi-County Blvd., Farmingdale, New York 11735 ("Procurement"). Collectively, BBBL and Procurement shall be know as "the Parties."

WHEREAS, BBBL wishes to transfer all its trademarks and service marks including applications for registration of such trademarks and service marks (collectively "the Marks") and the goodwill associated therewith and Procurement wishes to own the Marks including the goodwill associated therewith; and

WHEREAS, BBBL and/or its licensees have used the Marks or have a *bona fide* intention to use the Marks in connection with its existing and ongoing business;

NOW, THEREFORE, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. BBBL hereby assigns, transfers and conveys all right, title and interest in and to all the Marks owned by BBBL throughout the world, regardless of whether or not such marks are registered with any governmental agency anywhere in the world, to Procurement. Such assignment to Procurement includes all the goodwill associated with the Marks and all the business of BBBL associated with the Marks, which BBBL acknowledges is ongoing and existing. This Assignment includes the right

of Procurement to sue for and collect damages for acts of infringement, dilution, unfair competition and the like that occurred prior to the execution of this Assignment.




