

## TERMINATION AND REASSIGNMENT

This Termination and Reassignment is by Fleet National Bank f/k/a Bank of Boston Connecticut ("**Fleet**"), a national banking association having an office and principal place of business at 777 Main Street, Hartford, CT 06115, in favor of Ansonia Copper & Brass, Inc. ("**Ansonia**"), a Connecticut corporation having an office and principal place of business at 75 Liberty Street, Ansonia, CT 06401, and is made this 28 day of March, 2001.

### WITNESSETH:

**WHEREAS**, Ansonia and Bank of Boston Connecticut are parties to a loan and security agreement (the "**Loan Agreement**"); and

**WHEREAS**, as security for the obligations of Ansonia under the Loan Agreement, and all other financing documents executed in connection therewith (the "**Obligations**"), Ansonia and Bank of Boston Connecticut entered into an agreement dated August 28, 1991 (the "**Agreement**"), which document was recorded with the United States Patent and Trademark Office on December 9, 1991 on Reel 5947 at Frame 393; and

**WHEREAS**, Ansonia has notified Fleet of its desire to pay in full all of the Obligations and Fleet has agreed to execute this Termination and Reassignment, in consideration of said repayment of the Obligations in full;

NOW THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which hereby acknowledged by Fleet, Fleet hereby agrees as follows:


1. The Agreement shall be and is fully and forever terminated and extinguished.
2. Fleet hereby reassigns all right, title and interest to Ansonia, including goodwill, assigned, granted or conveyed to Fleet by Ansonia, including any and all right, title and interest, including goodwill, assigned, granted or conveyed to Fleet by the Agreement, and also including any and all right, title and interest in any and all registered trademarks, trademark licenses, patent licenses, patent applications and the like, listed in, or attached to, the Agreement.
3. All duties or other obligations of Ansonia under the Agreement are hereby terminated.

4. Fleet warrants that it has the unqualified right to enter into this Termination and Reassignment and to release Ansonia in accordance with the terms herein.

IN WITNESS WHEREOF, the Fleet National Bank has executed this Termination and Reassignment on the date set forth above.




