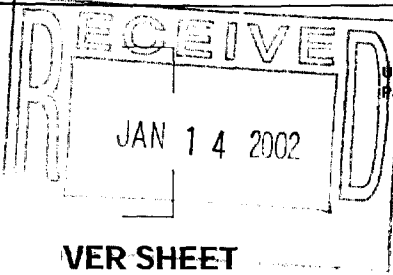
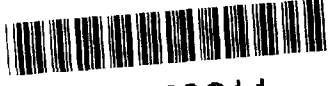

WHEREAS, the Assignor has adopted and used in the United States the trademark listed on Schedule A hereto (the "Trademark"); and


WHEREAS, the Assignee wishes to acquire all of Assignor's rights in and to the Trademark and any registration thereof, and the goodwill associated with such Trademark.
