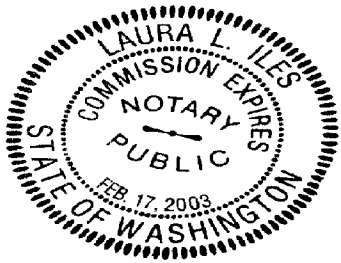
2. **WHEREAS**, the Assignor is the owner of U.S. Trademark Registration Number 755,369 for STABILAIRES; and
