

Trademark and Trade Name Assignment Agreement

THIS TRADEMARK AND TRADE NAME ASSIGNMENT AGREEMENT

("Agreement") is made and entered into by and between Lincoln Industrial Corporation ("LI"), a Minnesota Corporation having its principal place of business at One Lincoln Way, St. Louis, Missouri 63120, Lincoln Automotive Company ("LA"), a Minnesota corporation having its principal place of business at 9231 Penn Avenue South, Bloomington, Minnesota 55431 and McNeil (Ohio) Corp. ("McNeil"), a Minnesota corporation having its principal place of business at 1500 Country Road B2West, St. Paul, Minnesota 55113-3105.

WHEREAS, LI is a wholly-owned subsidiary of Pentair, Inc. ("Pentair") doing business in the field of lubrication equipment; and

WHEREAS, LA is a wholly-owned subsidiary of Pentair doing business in the field of automotive service equipment; and

WHEREAS, McNeil is a wholly-owned subsidiary of Pentair dealing with lubrication equipment; and

WHEREAS, LI uses certain trademarks in connection with the sale of lubrication equipment, and LA uses certain trademarks ("*LA Trademarks*") and trade names ("*LA Trade Names*") in connection with the sale of automotive service equipment; and

WHEREAS, McNeil owns a series of trademark registrations for goods relating to lubrication equipment ("*McNeil Trademarks*") and has licensed LI and LA to use such McNeil Trademarks; and

WHEREAS, Pentair has decided to consolidate all lubrication equipment business in LI; and

WHEREAS, in view of such consolidation, it is the intent of the parties that LA assign to LI all LA Trademarks and LA Trade Names, and that McNeil assign to LI all McNeil Trademarks, and that LI shall thereafter grant to LA a limited license to use LA Trade Names and Trademarks in connection with jacks and related products.

NOW, THEREFORE, in consideration of the sum of one dollar (\$1.00) and of the mutual promises hereinafter set forth, the parties agree as follows:

1. **DEFINITIONS.**

- 1.1 "*Agreement*" is defined as in the preamble above.
- 1.2 "*Effective Date*" shall mean October 23, 2001.
- 1.3 "*LA*" is defined as in the preamble above.
- 1.4 "*LA Trademarks*" shall mean the trademarks, including common law marks, owned by LA which are assigned to LI in this Agreement, as set forth in the attached Exhibit A of this Agreement.
- 1.5 "*LA Trade Names*" shall mean the trade names "Lincoln", "Lincoln Automotive," and any other trade name(s) incorporating the word "Lincoln" used by LA.
- 1.6 "*LI*" is defined as in the preamble above.
- 1.7 "*McNeil Trademarks*" shall mean the trademarks, including common law marks, owned by McNeil which are to be assigned to LI in this Agreement and which are set forth on the attached Exhibit B of this Agreement.
- 1.8 "*McNeil*" is defined as in the recitals above.

2. **REPRESENTATIONS AND WARRANTIES**

- 2.1 LA represents and warrants that as of the Effective Date, it owns all right, title, and interest throughout the world in and to the LA Trademarks.

2.2 Except for the McNeil Trademarks that have been previously assigned to Lincoln Industrial, McNeil represents and warrants that as of the Effective Date, it owns all right, title, and interest throughout the world in and to the McNeil Trademarks.

3. **ASSIGNMENT**

3.1 LA does hereby sell, assign, and transfer to LI, its successors and assigns, all of LA's right, title and interest throughout the world in and to the LA Trademarks and LA Trade Names and all goodwill associated therewith, including full rights to sue for and recover all profits and damages recoverable from past infringements of the LA Trademarks and/or LA Trade Names.

3.2 McNeil does hereby sell, assign, and transfer to LI, its successors and assigns, all of McNeil's right, title and interest throughout the world in and to the McNeil Trademarks and all goodwill associated therewith, including full rights to sue for and recover all profits and damages recoverable from past infringements of the McNeil Trademarks.

3.3 The parties agree that LI, its successors and assigns, shall own all right, title and interest throughout the world in and to the LA Trademarks, LA Trade Names and McNeil Trademarks and shall hold and enjoy the LA Trademarks, LA Trade Names and McNeil Trademarks as fully and entirely as the same would have been held and enjoyed by LA and McNeil had this assignment not been made.

3.4 LA and McNeil agree to execute all documents necessary for recordal in the United States Patent and Trademark Office to evidence the assignment of the LA Trademarks and McNeil Trademarks herein.

4. **USE OF THE LA TRADEMARKS, LA TRADE NAMES AND MCNEIL TRADEMARKS**

4.1 McNeil hereby agrees to cease all use of the McNeil Trademarks assigned and transferred to LI herein. LA hereby agrees to cease all use of the LA Trademarks and LA Trade Names assigned and transferred to LI herein, except as set forth in Subparagraph 4.2 below.

4.2 LI agrees to license LA to use particular "Lincoln" trademarks and the "Lincoln Automotive" trade name under the terms and conditions set forth in the Trademark and Trade Name License Agreement attached as Exhibit C executed on or about the Effective Date of this Agreement by and between LI and LA.

5. **MISCELLANEOUS**

5.1 Entire Agreement. This Agreement, including all attached Exhibits, shall constitute the entire agreement between the parties. To the extent the terms of this Agreement are inconsistent with prior agreements, this Agreement supercedes and replaces all prior oral or written understandings or agreements of the parties hereto relating to the subject matter herein.

5.2 Governing Law. The parties agree so far as possible to use every reasonable effort to settle any dispute or disagreement between them relative to this Agreement by amicable means and not to resort to legal

action unless and until the parties have in good faith attempted to settle such disputes or disagreement amicably. This Agreement shall be governed by and construed in accordance with the laws of the State of Minnesota, and the parties hereby consent to jurisdiction and venue in the state and federal courts sitting in the State of Minnesota.

5.3 Severability. If one or more provisions of this Agreement shall be held by a court of competent jurisdiction to be invalid, illegal, or unenforceable, the remaining provisions shall remain in full force and effect to the maximum extent allowed by law, and the invalid provision(s) shall be deemed severed from this Agreement.

5.4 Modifications and Amendments. This Agreement may not be modified or amended except in a writing subsequent to the Effective Date hereof and signed by both parties.

5.5 Exhibits. This Agreement includes Exhibits A and B, which are hereby incorporated by reference. Should the terms or provisions of this Agreement be found to conflict with any of the exhibits, the Agreement shall control.
