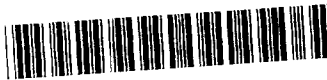


WHEREAS, ASSIGNOR and ASSIGNEE wish to memorialize said acquisition in an instrument suitable for recording;


