RELEASE OF A TRADEMARK ASSIGNMENT FOR SECURITY dated as of October 11, 2001 (this "Release") made by FLEET NATIONAL BANK, successor to BANKBOSTON, N.A., as Collateral Agent (the "Assignee") in favor of WATERBURY COMPANIES, INC. a Delaware corporation (the "Assignor").


