RELEASE OF SECURITY AGREEMENT
(TRADEMARKS)

WHEREAS, FULL LINE DISTRIBUTORS, INC., a Georgia corporation (herein referred to as "Company"), owns certain trademark applications/registrations in the United States Patent and Trademark Office, more particularly described on Schedule A annexed hereto and made a part hereof (the "Trademarks");
