DECLARATION UNDER 37 C.F.R. § 2.20

Sir:

I Daniel H. Rose declare that I am an officer, namely the Chief Executive Office, Secretary and Treasurer, of Edcor Data Services Corporation (“Edcor”), the current owner of the subject Registration and I am authorized to make this Declaration on behalf of the Edcor Data Services Corporation;

that the Lutz Associates Limited Partnership (the “Partnership”) was a State of Michigan partnership formed on December 3, 1990;

that on January 5, 1993, the Partnership filed a d/b/a for the name “edcor Data Services”;

that the Partnership filed an application to register the mark and logo “edcor Data Services” on August 22, 1994, which resulted in US Registration No. 1,916,745, issued on September 5, 1995;

that the partners of the Partnership changed but all transferring or withdrawing partners assigned all of their interest in the Partnership to a new partner or back to the Partnership upon withdrawal;

that on January 1, 1996: the entity name of the Partnership was changed to "edcor Limited Partnership;"

that edcor Corporation ("edcor DE Corp"), a Delaware Corporation, was incorporated on November 25, 1998; that edcor DE Corp later changed its corporate name to edcor Data Services Corporation; that all of the remaining partners of the Partnership assigned their entire interest in the Partnership to edcor DE Corp in exchange for common stock of edcor DE Corp; that with these assignments it was the intent the Partnership be extinguished;

that edcor Acquiring Corporation ("Edecor"), a Michigan corporation was formed on February 2, 2001;

that on March 1, 2001, edcor DE Corp merged with Edecor (the "Merger"); that it was the intent that the result of the Merger be that Edecor would be the surviving corporation of the Merger and that edcor DE Corp would be effectively dissolved; and

that on March 1, 2001, Edecor changed its name to "edcor Data Services Corporation;"

that none of the above identified transfers of ownership and name changes have been recorded in the PTO Assignment Division; and

that I am hereby warned that willful false statements and the like are punishable by fine or imprisonment, or both, under 18 U.S.C. § 1001, and that such willful false statements and the like may jeopardize the validity of this document; that I am properly authorized to execute this document on behalf of Edecor; and that all statements made of my own knowledge are true and that all statements made on information and belief are believed to be true.
