

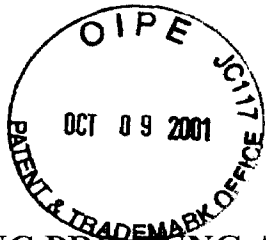

**NUNC PRO TUNC ASSIGNMENT OF TRADEMARKS,


