1. The present name of the Corporation is Spot Quotations and Data, Inc. The name under which the Corporation was organized was SQAD Inc.


2. The Certificate of Incorporation of the Corporation was filed with the Secretary of State on June 25, 1990.


3. The following amendment was authorized by unanimous written consent of the Corporation's Board of Directors and by unanimous written consent of the Corporation's shareholders:
