## MASTER ASSIGNMENT

THIS ASSIGNMENT, effective as of December 22, 1998, is from Greenleaf Corporation, a Pennsylvania corporation having a place of business at 18695 Greenleaf Drive, Saegertown, Pennsylvania 16433 ("Greenleaf") to Greenleaf Technology Corporation, a Delaware corporation having a place of business at 103 Springer Building, 3411 Silverside Road, Wilmington, Delaware 19801 ("GTC")

### WITNESSETH:

WHEREAS, Greenleaf is the owner of certain intellectual property relating to Greenleaf's business;

WHEREAS, Greenleaf desires to assign to GTC, its wholly owned subsidiary, all of Greenleaf's right, title and interest in and to said intellectual property and GTC desires to accept such assignment.

### ARTICLE 1

#### DEFINITIONS

As used in this Assignment, the following terms will have the meanings set forth as follows:

1.1 "Greenleaf Intellectual Property" means all rights of Greenleaf anywhere in the world, including those arising under contract or under statutory or common law, in and to any (i) copyright and all registrations and renewals thereof, including those set forth in Exhibit A, (ii) United States and foreign patent and patent application, including those set forth on Exhibit B, and any improvement thereof, (iii) invention certificate, industrial design, industrial model and utility model relating thereto and any improvement thereof, (iv) trademarks, trade names and service marks, and applications and registrations therefor identified in Exhibit C together with the goodwill of Greenleaf's business in connection with which said trademarks, trade names and service marks are used, (v) trade secret, know-how, invention, discovery, shop right and technical information, including those set forth on Exhibit D, and (vi) license rights to any of (i) through (v) which Greenleaf has the right to assign.

ARTICLE 2

ASSIGNMENTS BY GREENLEAF

2.1 Greenleaf hereby transfers, conveys and assigns to GTC Greenleaf's entire right, title and interest in and to the Greenleaf Intellectual Property, including the right to sue for past, present or future infringements of the Greenleaf Intellectual Property.

2.2 Greenleaf will at any time execute such further and additional documents as may be deemed necessary by GTC to carry out the purposes and intent of this Assignment.
