USF&G Realty represents and warrants to The St. Paul Companies, Inc. that this Assignment has been duly executed and delivered by USF&G Realty; that this Assignment is a legally valid and binding Assignment by USF&G Realty; that USF&G Realty has good title to its Interest in aforesaid intangible property, free and clear of any claims, liens, encumbrances, security interests, or options; and that this Assignment will pass to the assignees good title clear of any claims, liens, encumbrances, security interests, or options whatsoever.

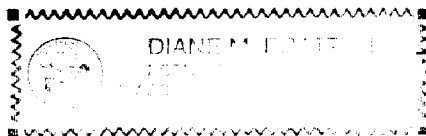
