That the Institution has attached any additional information required, pursuant to 12 C.F.R. Sections 544.2, 544.5, 552.4 or 552.5;


That the proposed amendment would not render more difficult or discourage a merger, proxy contest, the assumption of control, the removal of incumbent management or involve a significant issue of law or policy;

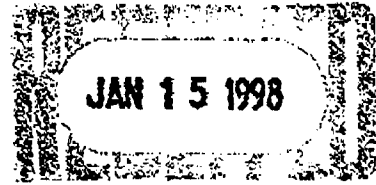
