RELEASE OF TRADEMARK

THIS RELEASE dated as of November 16, 2001 and effective as of January 28, 2000 ("Release") is made by Canadian Imperial Bank of Commerce, a Canadian chartered bank ("Secured Party") under that certain Security Agreement dated as of October 4, 1988 (the "Agreement"), from Pursley Inc. (the "Debtor").

WHEREAS, pursuant to the Agreement and recorded in the records of the United States Patent and Trademark Office on October 3, 1994 beginning at Reel 1224/Frame 0376, from the Debtor in favor of Secured Party, the Debtor granted to Secured Party, a continuing security interest in all of the Debtor's Charged Premises (as defined in the Agreement) including the trademark CON-DUCT and registrations therefor, including but not limited to U.S. Registration No. 1,226,515 issued February 8, 1983 (collectively the "Trademark");

WHEREAS, the Secured Party wishes to release all of its interest in the Debtor's Charged Premises and the Trademark;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party does hereby release, without any representation or warranty whatsoever, its security interest in, to or under all of the Charged Premises of the Debtor, including in the Trademark, granted to the Secured Party pursuant to the Agreement, together with the goodwill of the business symbolized by the Charged Premises and any right, title and interest of the Secured Party in, to and under the Trademark shall hereby cease and become void.

Secured Party shall execute any further documents as may be reasonably requested by the Debtor in order to fully effectuate the release of its security interest in the Debtor's Charged Premises as contemplated herein and authorizes Choate, Hall & Stewart to file evidence of Release or any such other documents as may be necessary to confirm or give effect to the terms hereof. *subject to payment of CIBC's fees and cost in connection with such execution.*

IN WITNESS WHEREOF, the Secured Party has caused this Release to be duly executed and delivered by its officer thereunto duly authorized as of the date first above written.
