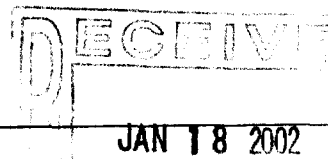



## ASSIGNMENT OF UNITED STATES TRADEMARKS

WHEREAS, GEORGIA-PACIFIC CORPORATION, a Georgia corporation having a principal address at 133 Peachtree Street, N.E., Atlanta, Georgia 30303 ("Assignor"), is the owner of the entire right, title, and interest in and to and has used and is using the following trademarks identified in the attached Schedule A currently registered in the U.S. Patent and Trademark Office ("Trademarks"):

the same to be held and enjoyed by Assignee, for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives, for the full life of the Trademarks as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made. This Assignment includes the right to file additional Trademark registration applications under any convention or treaty, to claim priority in such applications based upon current Trademark applications and registrations, and to sue, seek injunctive relief, and collect damages and profits for past infringement.

Assignor authorizes the United States Patent and Trademark Office and comparable government authorities in other countries to transfer by assignment to Assignee the existing Trademark registrations and to issue to Assignee all new Trademark registrations hereafter granted.

Assignor agrees to execute and deliver, at the reasonable request of Assignee, all papers, instruments, and assignments, and to perform other reasonable acts Assignee may require, to vest in Assignee all of Assignor's right, title and interest in and to the Trademarks, and to provide evidence to support the foregoing in the event such evidence is deemed necessary by Assignee to the extent such evidence is in the possession or control of Assignor.

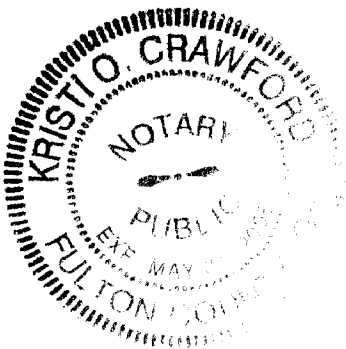
