FIRST: The name of the Company is Yurie Systems, Inc.

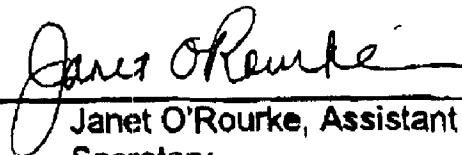
SECOND: The Company hereby amends its Certificate of Incorporation as follows:

FIRST: The name of the corporation (hereinafter called the "corporation") is Lucent Technologies Optical Specialty Fibers Inc.

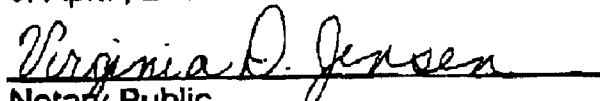
