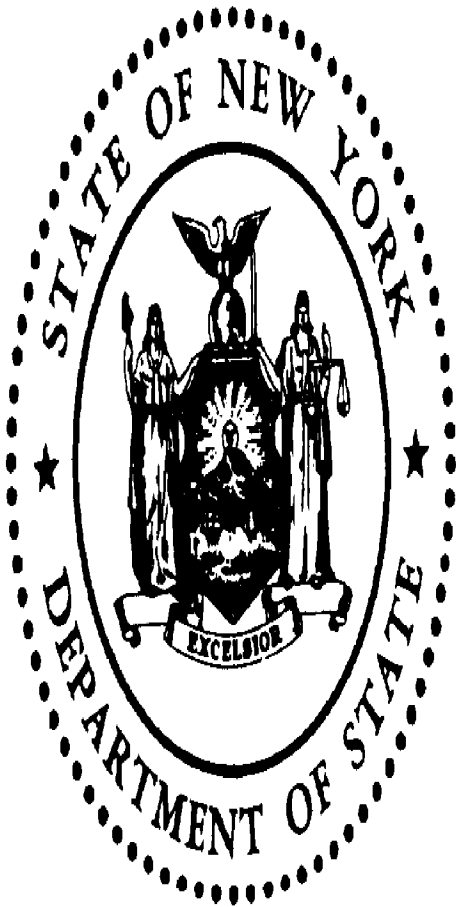

NAMDRMC, INC.

UNDER SECTION 805 OF THE BUSINESS CORPORATION LAW

1. The name of the corporation is NAMDRMC, Inc. (the "NAMDRMC").
2. The Certificate of Incorporation as in effect on the date hereof of said corporation was filed by the Department of State of New York on September 10, 2001.
3. (a) The Certificate of Incorporation is amended to change the name of the corporation to "Integrus Metals, Inc."

(b) To effect the foregoing, Article I is amended to read as follows:

"The name of the corporation is Integrus Metals, Inc. (the "Corporation")."
