CONFIRMATORY ASSIGNMENT OF TRADEMARKS

WHEREAS, pursuant to an Asset Purchase Agreement dated August 26th, 2000 (The "Purchase Agreement") **TMD FRICTION EUROPE GMBH**, (Formerly JFP Hundertsiebenundzwanzigste Vermögensverwaltungsgesellschaft mbH) a German Corporation with its principal place of business at Jagerstrasse 1-25, 51375 Leverkusen, Germany ("Assignee"), acquired from **BBA GROUP PLC**, an English company with offices at 70 Fleet Street, London, EC4Y 1EU, England ("Assignor"), all right, title and interest in and to the trademarks listed on Schedule 1 hereto, and all other registration and applications related thereto (hereinafter, the "Trademarks"), together with the goodwill of the business symbolised by the Trademarks; and

WHEREAS, pursuant to the Purchase Agreement, Assignor assigned to Assignee all of the right, title and interest in and to the Trademarks;

WHEREAS, Assignor intended that all goodwill of the business symbolised by the Trademarks be assigned under the Agreement, and agreed that such goodwill was in fact part of the assignment; and

WHEREAS, Assignor and Assignee wish to confirm that Assignee has acquired the entire right, title and interest in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

1. Effective August 26 2000, the date of closing under the Purchase Agreement, Assignor does hereby assign, sell, transfer, convey and grant to Assignee, its successors and assigns, the entire right, tile and interest in and to the Trademarks, together with the goodwill of the business symbolised by the Trademarks, including the right to apply for all renewals with respect for the Trademarks, from the effective date hereof, the same to be held and enjoyed by Assignee, its successors and assigns to the same extent that it would have been held and enjoyed by the Assignor if this Confirmatory Assignment of Trademarks had not been made.


