**TERMINATION AND RELEASE OF SECURITY INTEREST
IN PATENT AND TRADEMARK RIGHTS**

TERMINATION AND RELEASE dated as of January 16, 2002 from JPMORGAN CHASE BANK (f/k/a/ CHEMICAL BANK), a New York banking corporation, as Agent (the "Lender") to S.D. Warren Company, a Pennsylvania corporation (the "Borrower").

WITNESSETH:

WHEREAS, pursuant to that certain Security Agreement dated as of December 20, 1994, made by the Borrower in favor of the Lender (the "Security Agreement"), a security interest (the "Security Interest") was granted by the Borrower to the Lender in certain collateral, including the Patent Collateral and Trademark Collateral (as each term is hereinafter defined); and

WHEREAS, the Security Agreement was recorded in the Patent Division of the United States Patent & Trademark Office on March 20, 1995 at Reel 7388 and Frame 0328; and

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent & Trademark Office on March 20, 1995 at Reel 1317 and Frame 0027; and

WHEREAS, the Lender now desires to terminate and release the entirety of its security interest in the Patent Collateral listed on Schedule A annexed hereto (the "Released Patent Collateral") and in the Trademark Collateral listed on Schedule B annexed hereto (the "Released Trademark Collateral");

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Patent Collateral and the Trademark Collateral pursuant to the Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Lender hereby states as follows:

1. Patent Collateral: The term "Patent Collateral," as used herein, shall mean all of the Borrower's right, title and interest of every kind and nature as of the date hereof in the Patents (including, without limitation, those items listed on Schedule A hereto). The term "Patents" shall have the meaning provided by reference in the Security Agreement.

2. Trademark Collateral: The term "Trademark Collateral," as used herein, shall mean all of the Borrower's right, title and interest of every kind and nature as of the date hereof in the Trademarks (including, without limitation, those items listed on Schedule B hereto). The term "Trademarks" shall have the meaning provided by reference in the Security Agreement.

3. Release of Security Interest: The Lender hereby terminates, releases and discharges its Security Interest in the Released Patent Collateral and Released Trademark

Collateral, and any right, title or interest of the Lender in such Released Patent Collateral and Released Trademark Collateral shall hereby cease and become void.

4. Further Assurances: The Lender hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts including, but not limited to, the filing and recordation of this Termination and Release with the United States Patent and Trademark Office, as may be reasonably necessary to effect the release of any Security Interest contemplated hereby.


