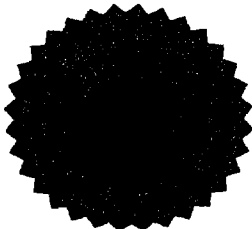

"The name of the corporation is "Sasol North America Inc."

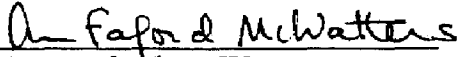
